Meeting Called to Order at 7:06 pm, by President, Jasmine Loggins

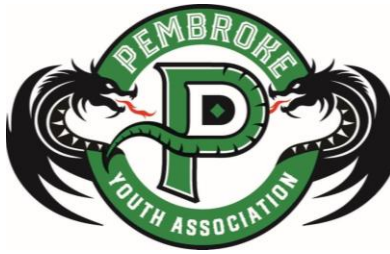
Pledge of Allegiance

Scholarship Committee: Sandra Lang, Katy Hobbs, Ashley Egloff, Cassandra Schmidt

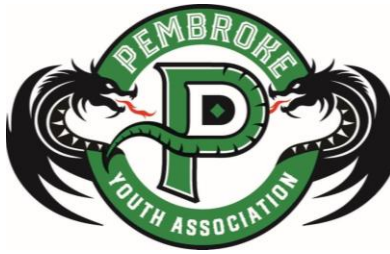
- Jasmine updated the website with the 2024 form. It is due March 31, 2024. She will create a Facebook post.
