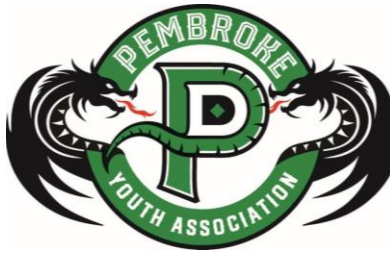
Meeting Minutes

Softball & Baseball by Russ & Cassandra Schmidt and Dan Ross

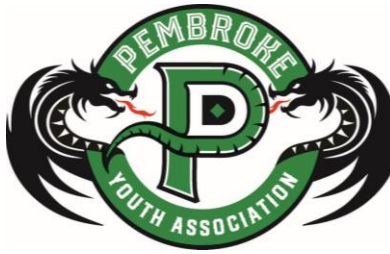
- We're at 191 kids registered for the season. We have made teams for older groups and have coaches. T-ball is still in the works. Still looking for one more coach.
