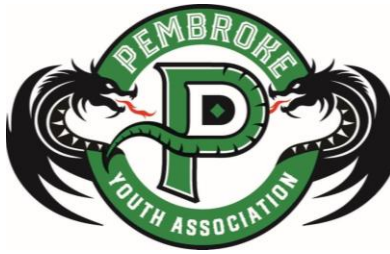
Meeting Minutes

- Boot Camp has 60 registrations. It will be held at the Primary School.

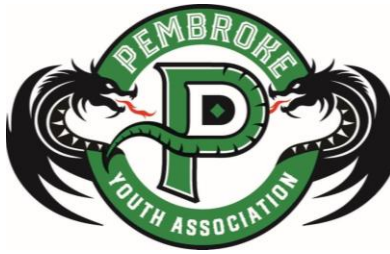
Committee Reports
