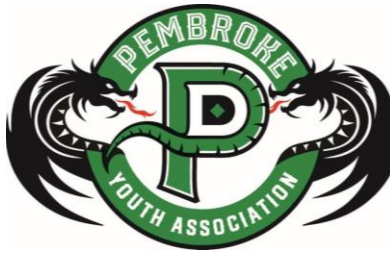
Meeting Minutes

- The next meeting is May 20.

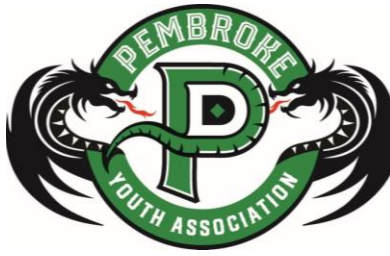
Cheerleading by Jasmine Loggins and Katy Hobbs
