Meeting Called to Order at 8:20 pm, by President, Jasmine Loggins

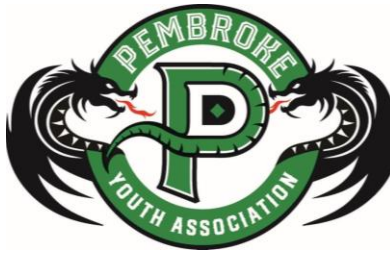

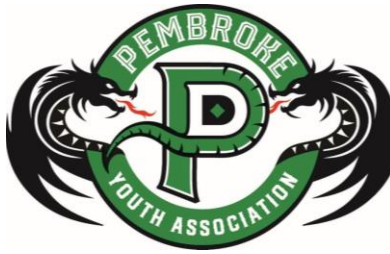
