Meeting Called to Order at 8:18 pm, by President, Jasmine Loggins

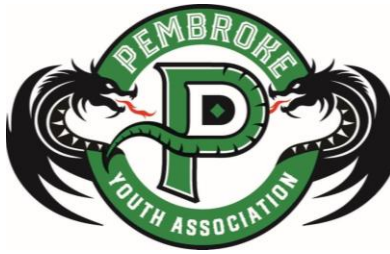

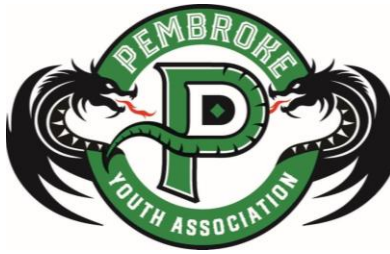
