Meeting Called to Order at 8:17 pm, by President, Jasmine Loggins

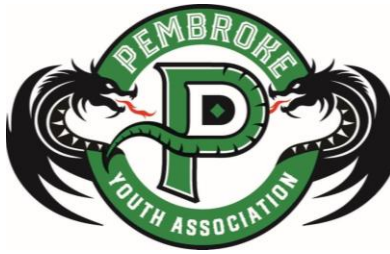

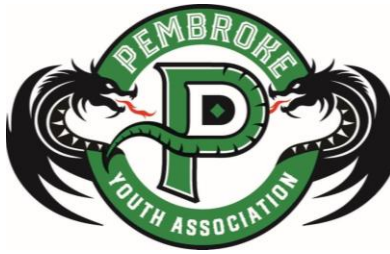
