Meeting Called to Order at 7:02 pm, by Vice President, Cassandra Schmidt

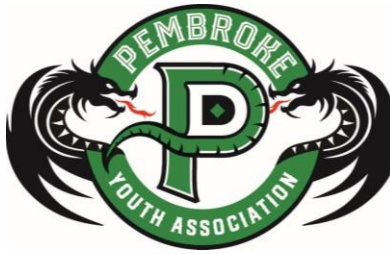
Pledge of Allegiance
