Meeting Called to Order at 7:07 pm, by President, Jasmine Loggins

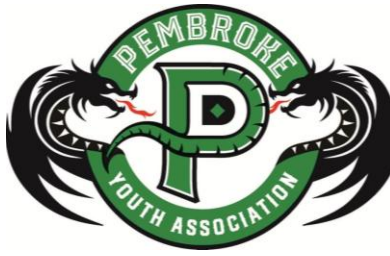

Concession Coordinator: by Cyndi Stewart

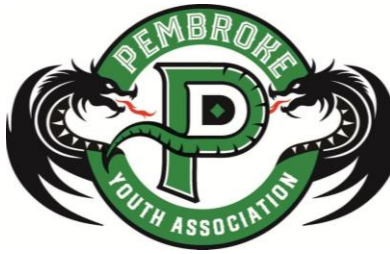
- Halfway through basketball. Had a lot of volunteers. People were given \$25 to volunteer. Two home games left.
