Meeting Called to Order at 7:08 pm, by President, Jasmine Loggins

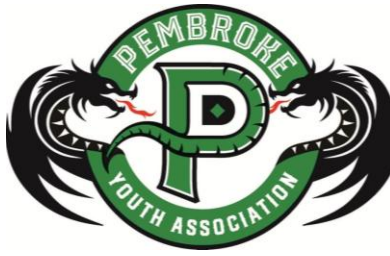
Pledge of Allegiance

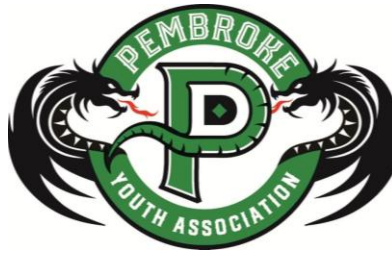
