Meeting Called to Order at 7:05pm, by President, Jasmine Loggins

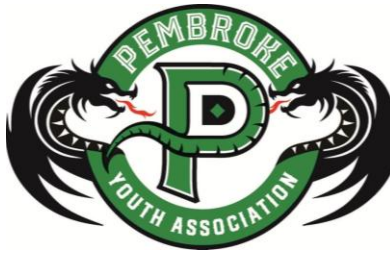
Pledge of Allegiance

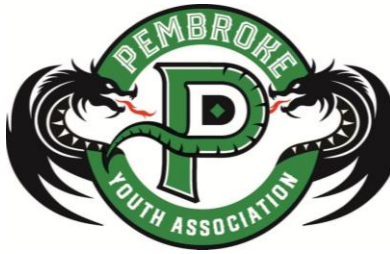
Committee Reports

- Proposed Bylaw: Grant Writing & Applications
Section X: Grant Applications
 1. All grant applications shall first be considered at the organizational level. The Association, as a whole, will make best efforts to pursue grants collectively when applicable.
 2. If an individual sport program wishes to pursue a grant opportunity independently, the request must be presented at a regularly scheduled Board meeting prior to submission.
 3. The Board must approve the application by majority vote before the individual sport may proceed.
 4. No grant application may be submitted in the Association's name, or using its tax identification number, without prior Board approval.
 5. All funds received through approved grants must be deposited into the Association's accounts and managed according to the Association's financial policies.
