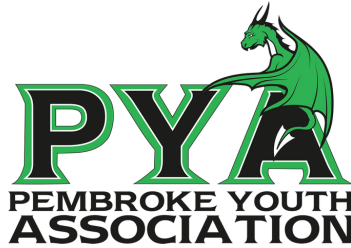

### **HS Basketball** by Matthew Shay

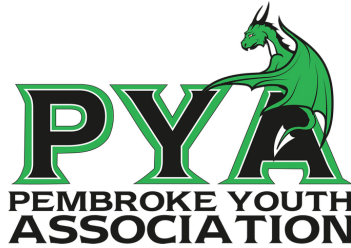
- Nothing to report - Absent

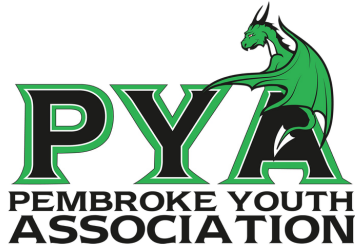
