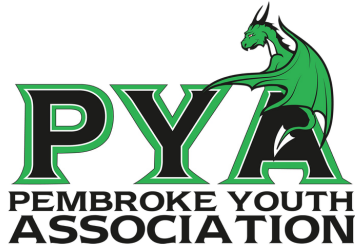

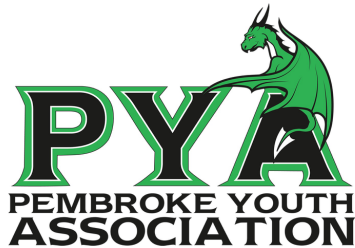
Treasurer's Report

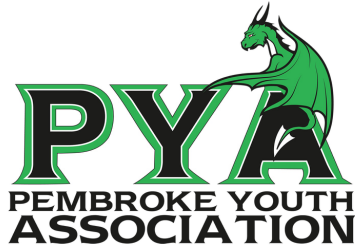
