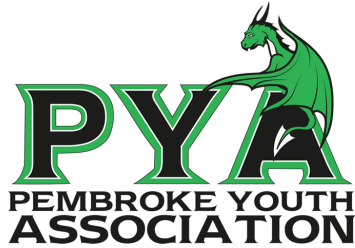

 - Membership Approved.

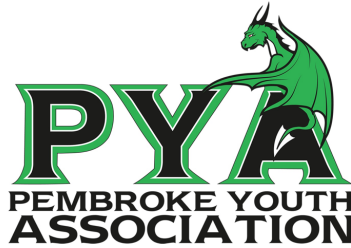
Treasurer's Report

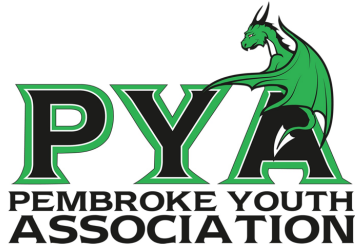
