Regardless of how all members feel with regards to voting, only ONE vote is allowed per household membership

- All children in immediate family to participate in PYA sports at a discounted rate.

In requesting membership in PYA you agree to:

- Attend at least three (3) FULL meetings in a calendar year (January –December) with all 3 meetings being attended by the year’s final December meeting.
- Volunteer in 4 PYA functions per calendar year. Volunteer activities will be tracked and confirmed by each sport commissioner. Examples of volunteer activities include but are not limited to Sport Commissioner, Coach, Assistant Coach, Team Parent, Food Booth, Team Statistician, Chain Crew, Booth Announcer etc).
- Pay all fees that may apply according to each sport.

Digital Signature

PYA membership fee is \$20.00 for both an individual or household membership. Members in good standing will receive a 20% discount per sport, per child. Registration fees must be paid in full at the time of registration and the discount will be awarded/refunded at the end of the sport season and/or with the completion of PYA membership requirements according to Article 4 Number 4 in the PYA Bylaws. All additional fees not related to registration are not discounted or waived and must be paid in full.

Membership dues may be paid by cash or check made payable to Pembroke Youth Association and must be received at the time of application.

No new members will be accepted after September 1st of each year due to the 3 meeting requirement before the end of each calendar year.

Membership is valid for one (1) calendar year (January through December) and must be renewed annually.

PYA is strictly a volunteer, non-profit organization that offers children in the community the opportunity to participate in team sports and activities.
